Tavani, 821 Ridge Avenue, Stormwater Management Small Project Agreement, Subject to the Borough Engineer Approving the Plan and Documents – Motion to approve made by Hahn/McClay. Ms. Andrews said the improvement is an in-ground swimming pool and impervious coverage. All members were in agreement.

<u>Change Order #1, Generator and Site Security Upgrade Project, Value: \$11,649.56</u> – Motion to approve made by Hahn/Glick. The change order is for an electric sliding gate with remote openers for the West End Pump Station. All members were in agreement.

Waive Utility Late and Delinquent Fees Effective April 1, 2020 to June 30, 2020 – Due to the COVID-19 pandemic, the Governor's Stay at Home orders, and the economic impact this health crisis is having on the community a motion was made by Glick/Hahn to waive utility late fees and delinquent fees effective April 1, 2020 to June 30, 2020. All members were in agreement. Water shut-offs are in abeyance during this time frame.
