PLEDGE OF ALLEGIANCE AND ROLL CALL BY MAYOR

Mayor Hodorovich asked Father Sean O'Neill to do the invocation. At the conclusion of the invocation Mayor Hodorovich led the pledge of allegiance and took roll call.

NOMINATION AND ELECTION OF PRESIDENT

The Mayor asked for nominations for President. Mr. Hahn nominated Charles H. Palmer Jr. Even though a second was not needed, Ms. McClay seconded the nomination. There were no other nominations. Mayor Hodorovich called for a vote. The vote was unanimous to elect Charles H. Palmer Jr. as President.

NOMINATION AND ELECTION OF VICE PRESIDENT

The Mayor asked for nominations for Vice President. Ms. McClay nominated Brian Hahn. Mr. Palmer nominated Joshua Glick. There were no other nominations. Mayor Hodorovich called for a roll call vote for Brian Hahn for Vice President. The vote was as follows: Yes – McClay. No – Palmer, Glick, Hahn. POLICE REPORT – Officer Moore read aloud the December police activity report.

<u>Christiana Borough Police Officers Providing Police Service to Atglen Borough, Resolution # 610-20</u> – Motion to approve made by Hahn/McClay. All members were in agreement.

<u>December 2, 2019 Council Minutes, December Treasurer's Report, Bills of Approval, Department and Advisory Reports</u> – Motion to approve made by Palmer/Glick. All members were in agreement.

COUNCIL DISCUSSION ITEMS

<u>Council Member Vacancy</u> – Ms. Andrews said the vacancy occurred today. Council has 30 days to fill. George Stewart submitted a letter of interest. There was a discussion about appointing this evening or advertising the position. It was agreed to advertise on social media.

<u>Council Member Appointment to the Master Parks Study Committee</u> – Ms. Andrews said there is an open slot for a Council member to sit on the Master Parks Study Committee. Mayor Hodorovich sits on the Committee. Council said to move this topic to the February agenda when the new Council member is appointed.

<u>Park & Recreation Commission Vacancy</u> – Ms. Andrews said the position was advertised. Peggy Kellar and George Stewart submitted a letter of interest. Mr. Stewart said he wanted to encourage the community to get involved and is removing his name. Ms. Kellar introduced herself and answered questions. <u>A motion was made by Hahn/Glick to appoint Peggy Kellar to the Park and Recreation Commission</u>. All members were in agreement.

AJ Blosenski Trash and Recycling Collection, Holiday Schedule Request – AJ Blosenski submitted a request to alter some of the trash collections days due to Monday holidays. Council said no. Trash pickup will remain on Wednesdays.

No Hunting Ordinance # 153, Enacted April 3, 1972 – Ms. Andrews said the PA Game Commission Officer stopped by Borough Hall and discussed with her the No Hunting Ordinance. He said it is invalid. She forwarded this issue to the Borough Solicitor. The Solicitor recommends the ordinance be repealed. Council asked Ms. Andrews to proceed with preparing the legislation.

<u>Retired Telephones</u> – The new phones are operational in Borough Hall. We have a few phones to donate or sell. Council said to proceed.

PARK AND RECREATION COMMISSION, UPDATE

Emily Reid said the last two months the Commission did not meet due to attendance issues. Twenty houses registered for the Winter Wonderland Holiday Lighting and Decoration contest winners. The Commission selected three winners.

MANAGER'S COMMENTS

Ms. Andrews said the Solicitor has completed her review of the pension ordinance. She expects the ordinance to be ready for Council consideration at the February meeting. Ms. Andrews said we are entering the CRP and CDBG grant application season. Ms. Andrews read aloud her report and responded to questions.

Emily Reid asked if fencing is planned for the Penningtonville Meadow Pump Station. Ms. Andrews said yes.

VISITORS COMMENTS

George Stewart spoke about repealing the No Hunting Ordinance.

JUNIOR COUNCILPERSON'S COMMENTS

Sydney Burkhardt said the student body received Chromebooks; and, they were repaired over Winter break. The learning lab offers peer tutoring. The Winter sports have begun.

MAYOR'S COMMENTS

Mayor Hodorovich thanked everyone. He is looking forward to serving. Mayor Hodorovich discussed his priority projects.

COUNCIL MEMBER COMMENTS

Mr. Palmer said he received a plaque from the Western Chester County Council of Governments for the Borough's perfect attendance at the meetings.
